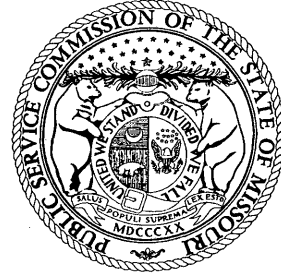

On April 10, 2008, the persons listed above received the attached electronic mail message and attachment. This case, **ER-2008-0093**, is a contested case. The Commission is bound by its *ex parte* rule, and, we are therefore giving notice to the parties this communication has been received.
