**NOTICE OF INTENDED CASE FILING**

COMES NOW Liberty Utilities (Missouri Water) LLC (“Liberty”), and, pursuant to Commission Rule 20 CSR 4240-4.017, submits this Notice of Intended Case Filing with regard to its intended application for a Certificate of Convenience and Necessity (“CCN”) authorizing Liberty to install, own, acquire, construct, operate, control, manage, and maintain a sewer system in Olympian Village, Jefferson County, Missouri. In this regard, Liberty respectfully states as follows to the Missouri Public Service Commission (the “Commission”):

1. Liberty is a Missouri limited liability company with its principal office located at 602 Joplin Street, Joplin, Missouri, 64801, and provides water and sewer services to customers in its Missouri service areas, as certificated by the Commission. Liberty is a “water corporation,” a “sewer corporation,” and a “public utility,” as those terms are defined by RSMo. §386.020 and, therefore, is subject to the general regulatory jurisdiction of the Commission as provided by law.

2. Sewer service to the area is currently provided by the City of Olympian Village, Missouri, and the sale of the sewer system was approved by a majority of all residents voting on the question in the City of Olympian Village municipal election held on June 2, 2020, as contemplated by RSMo. §88.770.

3. RSMo. §393.170 and Commission Rules 20 CSR 4240-2.060 and 20 CSR 4240-3.305 govern these types of applications. Issues the Commission will be asked to consider and decide in

the intended case are those that normally arise in CCN applications filed under the referenced statute and rules.

4. With regard to Rule 4.017(1) and the requirement that a 60-day filing notice include “a summary of all communication regarding substantive issues likely to be in the case between the filing party and the office of the commission that occurred in the ninety (90) days prior to filing the notice,” the Company verifies that there have been no ex parte communications regarding substantive issues likely to be in the intended case between Liberty and the office of the Commission within the 90 days prior to the filing of this Notice.

WHEREFORE, Liberty submits to the Commission this Notice of Intended Case Filing. The Company requests such relief as is just and proper under the circumstances.
