Dear Judge Woodruff:

We represent Vodafone US Inc. d/b/a Vodafone Americas. Our client wishes to provide a correction to Commission records.

In April 2014, in File No. XN-2014-0284, the Commission recognized a name change for our client to Vodafone US Inc. as an IXC. In October 2014, in File No. CA-2015-0070, the Commission approved the registration of our client as a CLEC under the name Vodafone US Inc. d/b/a Vodafone Americas. Our client intended to have the same name, including "d/b/a Vodafone Americas", apply to all services, but inadvertently did not update the Commission as to the IXC certification. It recently learned of this oversight.


Accordingly, pursuant to 4 CSR 240-2.062, our client notifies the Commission that its full name as to all services is Vodafone US Inc. d/b/a Vodafone Americas. As shown by the attached fictitious name registration, the company filed for use of this name with the Missouri Secretary of State in July 2014. As stated in the April 2014 filing, the company had no customers to notify of a name change at the time, and has only used the name as approved in the CLEC registration matter with Missouri customers. The company does not have tariffs to revise relative to this correction of Commission records.

The company has reviewed its contacts in the electronic filing and information system (EFIS) and no change is required.
