

NOTICE OF COMPLETION OF TRANSACTION

COME NOW Quail Run Water and Land Company ("Quail Run") and Public Funding Corporation of the City of Ozark, Missouri ("City of Ozark"), pursuant to the Commission's Order Approving Sale Of Assets entered in this matter on June 11, 2002, and respectfully state as follows:

1. In its Order Approving Sale of Assets, the Commission found: "In order to provide for as orderly a transfer as possible, the Commission will not cancel Quail Run's certificate and tariff, nor relieve Quail Run of its obligation to provide public water service in its designated service area, until the parties have notified the Commission that the transaction is complete." Accordingly, Ordered Paragraph 2 of the Commission's Order provides:


That the Public Funding Corporation of the City of Ozark, Missouri, and Quail Run Water and Land Company shall advise the Commission when the transaction approved above has been closed by filing a pleading in this case. At that time, the Commission will relieve Quail Run Water and Land Company of its obligation to provide water service to the public in its assigned service area and will cancel the certificate and tariff of Quail Run Water and Land Company.¹

2. Quail Run and the City of Ozark hereby notify the Commission that the subject transaction was closed on Friday, June 28, 2002, and that this matter is now complete.


