Dear Mr. Henderson:

The Missouri Public Service Commission ("Commission") granted Certificates of Service Authority to Now Acquisition Corporation ("Company") to provide basic local, intrastate interexchange, and nonswitched local telecommunications services within the State of Missouri in the above referenced matters.

The Company has since changed its corporate name in its state of incorporation to Now Communications, Inc. However, that name is unavailable for use by the Company in the State of Missouri. Accordingly, the Company has established the name "Now Communications, Incorporated of Delaware" for use in Missouri. Proof of the Company's filing with the Missouri Secretary of State is enclosed as <u>Exhibit A</u>. Additionally, the Company has registered the name of its parent company, "Cleartel Communications," for use by the Company as a fictitious name in the State of Missouri. Proof of the Company's filing with the Missouri Secretary of State is enclosed as <u>Exhibit B</u>

Consistent with the requirements of 4 CSR 240-2.060(5), also enclosed as <u>**Exhibit**</u> C is the statement of Keith Parsons, Secretary of the Company.

Also enclosed as **Exhibit D** is the Company's adoption notice and revised title pages of the Company's Mo. P.S.C. Tariff No. 1 and Mo. P.S.C. No. 2 reflecting the new corporate name pursuant to 4 CSR 240-3.545(20), as well as the fictitious name.
