**QUARTERLY STATUS REPORT
OF WORLDCOM, INC., AND ITS U.S. SUBSIDIARIES**

WorldCom, Inc., and its United States subsidiaries¹ that are authorized to provide telecommunications service in the state of Missouri (collectively WCom) file their joint quarterly status report as required by the Order Establishing Case of the Missouri Public Service Commission (Commission) in the above styled and numbered docket.

I. Current Status of Bankruptcy Case

On October 31, 2003, Judge Arthur Gonzalez of the United States Bankruptcy Court for the Southern District of New York confirmed WorldCom's Plan of Reorganization under Chapter 11 of the Federal Bankruptcy Code (the "Plan").² The Judge's action permits the Company to undertake the final steps necessary to consummate the Plan and to emerge from bankruptcy, which is anticipated in early 2004.
