Dear Secretary Woodruff:

By this letter, Securus Technologies, Inc. ("Securus, Inc.") notifies the Commission of the change in name of Securus, Inc. to Securus Technologies, LLC ("Securus, LLC"), which became effective at the end of the day on December 31, 2019. Securus, Inc. (ID 4622) is authorized to provide telephone services in the State of Missouri as a Private Pay Telephone Provider pursuant to a Certificate of Public Convenience and Necessity.

Securus, Inc. originally was incorporated as a State of Delaware corporation. Pursuant to Title 6, Section 18-214 of the Delaware Code, it has converted to Securus, LLC. Under that provision of Delaware law, there is no dissolution or termination of the converting business entity. No new legal entity is created and there is no legal transfer of assets or Securus, Inc.'s Missouri authorization as a result of the conversion – they remain with the same legal entity.¹ The conversion was implemented for tax and other business reasons.

Following the conversion, Securus, LLC continues to offer and/or provide the same services as the corporate entity offered prior to the conversion. There are no changes in the rates for or the nature or extent of services for customers as a result of the conversion. Further, there is no change in management or ownership of the company as part of the conversion. Securus, LLC continues to be located at 4000 International Parkway, Carrollton, TX 75007. Securus, Inc. has reviewed its contacts in the Electronic Filing and Information System and the contacts do not need to be updated.

Attached as Exhibit 1 is documentation showing that Securus, LLC is registered with the Missouri Secretary of State.
