**MOTION TO SUBMIT ADVISORY COMMISSION RECOMMENDATION  
FOR DISBURSEMENT FROM THE RECOVERY FUND**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through the undersigned counsel, on behalf of the Manufactured Housing Consumer Recovery Advisory Committee (“Committee”) for its Recommendation for Disbursement from the Missouri Housing Consumer Recovery Fund (“Recovery Fund”), states to the Missouri Public Service Commission (“Commission”) as follows:

1. The Recovery Fund is established for the purpose of paying consumer claims under commission created procedures.<sup>1</sup>
2. A committee shall assist in the evaluation of all claims submitted by consumers.<sup>2</sup>
3. The Commission promulgated Commission Rule 4 CSR 240-126 establishing the advisory committee,<sup>3</sup> setting forth the standards for consumers to receive disbursement from the Recovery Fund,<sup>4</sup> and the methods by which consumers may submit claims.<sup>5</sup>

4. The committee shall investigate and determine whether the requirements of this rule have been satisfied and present its findings to the Commission in the form of a recommendation within sixty (60) days of receipt of a claim form.<sup>6</sup>

5. All recommendations for disbursement of funds from the Recovery Fund shall be subject to approval of the Commission.<sup>7</sup>

6. Pursuant to the authorities granted by 700.041 RSMo., the committee investigated a consumer complaint filed with the Commission on April 5, 2013.

7. Pursuant to Commission Rule 4 CSR 240-126.020(4), the committee has prepared a recommendation for disbursement based on its investigation for the consideration and approval of the Commission.

**WHEREFORE**, the Committee submits this Recommendation for Disbursement for the Commission's approval.
