**ORDER APPROVING TARIFFS PURSUANT TO COMMISSION ORDER**

On November 27, 2000, Oregon Farmers Mutual Telephone Company (the Company) submitted to the Commission a tariff sheet designed to make permanent the interim revenue surcharge that it implemented pursuant to Reports and Orders issued in Case Nos. TO-99-507 and TO-99-254. In an order approving stipulation and agreement issued April 13, 2001, the Commission rejected that tariff sheet, but authorized the Company to file a new tariff sheet that complied with the order. On May 9, 2001, the Company filed a new tariff designed to comply with that order.

On May 23, 2001, the Staff of the Commission filed its recommendation to approve the tariff. In that filing, the Staff states that it has reviewed the tariff, finds that it is correct and complies with the Commission's order, and recommends approval.

The Commission has reviewed the tariff filing and the Staff memorandum and has determined the filing to be in compliance with the Commission's order.

**IT IS THEREFORE ORDERED:**

1. That the following tariff sheet filed May 9, 2001, by Oregon Farmers Mutual Telephone Company, and assigned Tariff File No. 200101109, is hereby approved as substituted for service on or after June 19, 2001:
