OF JOINT STIPULATION FILED DECEMBER 26, 2001**

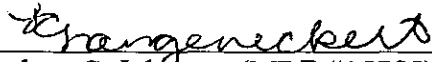
COMES NOW the Missouri Energy Group ("MEG"), and for its Motion in

1. The MEG supports the proposed procedural schedule filed herein in the
Joint Stipulation of the Staff of the Public Service Commission ("Staff") and AmerenUE if
(a) the Commission determines that it will not reconsider its December 7, 2001 Order
rejecting the June 30, 2000 test year originally proposed by the Staff of the Public Service
Commission and (b) AmerenUE is willing to make any rate refund that results from this
case retroactive to April 1, 2002. .

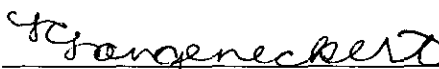
