SECOND MOTION FOR EXTENSION OF TIME FOR RESPONSE

COMES NOW Neutral Tandem-Missouri, LLC (Neutral Tandem), through undersigned counsel, and moves for the Commission to allow additional time, until November 9, 2009, for Neutral Tandem's response to AT&T's Motion to Suspend and Investigate Tariff (AT&T's Motion). In support of this motion, Neutral Tandem states as follows:

1. Neutral Tandem continues its efforts to address concerns raised in AT&T's Motion.
2. To accommodate additional time for discussions with AT&T and Staff, Neutral Tandem has extended the effective date of its proposed tariff for an additional 22 days, to November 20, 2009.
3. Neutral Tandem requests an extension of time for its response, to November 9, 2009.
4. Undersigned counsel has spoken with counsel for AT&T and Staff regarding this request. AT&T does not object to this request, contingent on extension of the tariff effective date.
5. Grant of this motion will facilitate the parties' attempts to resolve concerns with Neutral Tandem's tariff, and Neutral Tandem requests the Commission to postpone acting on Staff's request for a prehearing conference to be set at this time. In the event

the parties are unable to resolve this matter within the time frame requested herein, the passage of additional time will not adversely affect Staff or AT&T Missouri.

WHEREFORE, Neutral Tandem respectfully requests an Order of the Commission granting it additional time, to November 9, 2009, to file its Response to AT&T's Motion to Suspend and Investigate Tariff.
