# **Amendment**

to the Mutual Traffic Exchange Agreement between

New London Telephone Company and

Level 3 Communications, LLC

THIS MUTUAL TRAFFIC EXCHANGE AGREEMENT AMENDMENT (the "Amendment") is made by and between New London Telephone Company ("Company"), with its principal place of business at 101 N. Main, New Florence MO, 63363, and Level 3 Communications, LLC, ("Level 3") with a place of business of 1025 Eldorado Boulevard, Broomfield, CO 80021, in the state of Missouri ("State"). This Amendment may refer to either Company or Level 3 as a "Party" or collectively as the "Parties."

#### RECITALS

WHEREAS, the Parties entered into a Mutual ("Agreement") in the State which was executed by the Parties on August 4, 2006; and

WHEREAS, the Parties desire to amend the Agreement further under the terms and conditions contained herein.

### **AGREEMENT**

NOW THEREFORE, in consideration of the mutual terms, covenants and conditions contained in this Amendment and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

<u>Amendment Terms.</u> The Agreement is hereby amended replacing Schedule II, Points of Interconnection, in its entirety and is attached hereto and incorporated herein by this reference.

**Effective Date.** This Amendment shall be deemed effective upon execution.

<u>Further Amendments.</u> Except as modified herein, the provisions of the Agreement shall remain in full force and effect. The provisions of this Amendment, including the provisions of this sentence, may not be amended, modified or supplemented, and waivers or consents to departures from the provisions of this Amendment may not be given without the written consent thereto by both Parties' authorized representative.

**Entire Agreement.** The Agreement as amended (including the documents referred to herein) constitutes the full and entire understanding and agreement between the Parties with regard to the subjects of the Agreement as amended and supersedes any prior understandings, agreements, or representations by or between the Parties, written or oral, to the extent they relate in any way to the subjects of the Agreement as amended.
