## **NOTICE**

March 22, 2005

To: All certificated telecommunications companies (except payphone providers and shared tenant service providers).

This letter is to advise you that the Missouri Public Service Commission ("Commission") approved a schedule directing all certificated telecommunications companies, except payphone providers and shared tenant services providers, that they may begin billing their customers the Missouri Universal Service Fund ("MoUSF") surcharge on May 1, 2005, if applicable. On March 17, 2005, the Commission approved the attached schedule for implementing the Low-Income and Disabled portion of the MoUSF in Case No. TO-98-329. The Commission further ordered that requests for disbursements should be made by the 15<sup>th</sup> day of each month, and disbursements should be dispatched by the last day of each month.
