NOTICE OF DEFICIENCY AND ORDER DIRECTING FILING

On April 28, 2000, OnFiber Carrier Services, Inc. (OnFiber), filed an application for authority to operate as a local exchange, basic local exchange and interexchange provider of telecommunications services on a facilities and resale basis to customers throughout Missouri. Regulation 4 CSR 240-2.080(3) requires that such applications include a specific reference to the statutory or other authority under which relief is requested. A review of OnFiber's application indicates that the company did not provide the required reference.

IT IS THEREFORE ORDERED:

1. That OnFiber Carrier Services, Inc., is directed to file an appropriate pleading or other filing in order to comply with 4 CSR 240-2.080(3), no later than June 19, 2000.

2. That this order shall become effective on June 15, 2000.

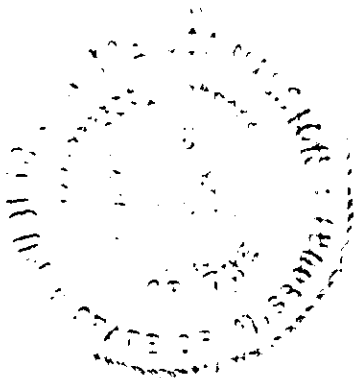
