ORDER SETTING PREHEARING CONFERENCE

On November 27, 2001, the Staff of the Missouri Public Service Commission filed its recommendation as directed by the Commission. Staff recommended an adjustment of \$5,886,058.13 to reduce Missouri Gas Energy's gas cost attributable to excessive transportation costs. Staff also recommended that the Company be directed to provide certain additional information regarding the reliability of its gas supply and the need for additional capacity, and that the case be held open pending resolution of other Missouri Gas Energy ACA cases (GR-96-450, GR-97-167, and GR-99-304).

On December 27, 2001, Missouri Gas Energy filed its Response to Staff's Recommendation and Motion to Dismiss or Strike. The Company opposes the Mid-Kansas Partnership/Riverside Pipeline Company adjustment proposed by Staff. The Company also asserts that Staff's Peak Day Requirements Study Recommendation is not a proper topic for consideration in this ACA proceeding, and requests that the Commission dismiss or strike Staff's Peak Day Requirements Study Recommendation from consideration in this ACA case. The Company generally agrees that this case should remain open but without a procedural schedule pending a "final, non-appealable Commission decision on the MKP/RPC adjustment in Case No. GR-96-450."

The Commission will schedule a prehearing conference in order to facilitate the resolution of this matter. The parties should be prepared to address, among other things, the effect of the Commission's Report and Order, issued March 12, 2002, in GR-96-450 on this case. The parties may also be questioned regarding the Company's Motion to Dismiss or Strike or regarding any other pleading. In addition, the parties should be able to discuss proposed procedural schedules.

IT IS THEREFORE ORDERED:

- 1. That a prehearing conference is scheduled for April 24, 2002, beginning at 10:00 a.m., in the Commission's offices in the Governor Office Building, 200 Madison Street, Room 305, Jefferson City, Missouri. The Governor Office Building meets accessibility standards required by the Americans With Disabilities Act.  - 2. That this order shall become effective on April 11, 2002.
