**ADDENDUM TO RESPONSE TO ORDER DIRECTING FILING**

**COME NOW** Kansas City Power & Light Company (“KCP&L”) and KCP&L Greater Missouri Operations Company (“GMO”), and file this Addendum to their Response to the Order Directing Filing, which provided certain information as directed by the Commission’s Order Directing Filing issued on April 12, 2013 (“Order Directing Filing”).

1. In its Order Directing Filing, the Commission ordered KCP&L and GMO, the applicants in File No. EO-2012-0367 (“Transfer Application”), to supplement the Transfer Application by listing each county in which any part of any affected political subdivision is located. See Order Directing Filing at 2. The Commission allowed KCP&L and GMO until April 19, 2013 to make such filing. Id.

2. On April 12, 2013 KCP&L and GMO filed their Response to the Order Directing Filing, which stated that the Transfer Application requests the Commission’s authority to transfer assets associated with the Iatan-Nashua Project. The Iatan-Nashua Project is located entirely within Platte and Clay counties. However, the Nashua substation and a very small portion of the transmission line are located in Kansas City, Missouri, which spans four counties: Platte, Clay, Jackson, and Cass.

3. KCP&L and GMO hereby add to their Response to Order Directing Filing the information provided orally at the hearing conducted on April 16, 2013 that Platte County Public Water Supply District No. 9, in which a small portion of the Iatan-Nashua Project transmission line will be located, serves customers in both Platte and Buchanan Counties.

4. While the Applicants understand that the Commission has consolidated the Transfer Application in File No. EO-2012-0367 with Transource Missouri, LLC's Certificate of Convenience and Necessity Application in File No. EA-2013-0098, KCP&L and GMO have sought relief only in No. EO-2012-0367. In its November 7, 2012 Order Consolidating Files, Setting Procedural Schedule, Establishing Discovery Guidelines, Granting Staff's Request to be Excused from Filing Report and Delegating Authority, the Commission consolidated these two cases, ordered No. EO-2012-0367 to be closed, and ordered that all filings in these two cases be exclusively made in No. EA-2013-0098. Thus, while Applicants KCP&L and GMO are hereby supplementing their Transfer Application filed in No. EO-2012-0367, they make this filing in the lead case, No. EA-2013-0098.

WHEREFORE, pursuant to the Order Directing Filing, KCP&L and GMO respectfully request that the Commission supplement the Transfer Application, No. EO-2012-0367, with the county information contained in paragraphs 2 and 3 herein.
