**NOTICE OF INTENDED CASE FILING**

COMES NOW Kansas City Power & Light Company (“KCP&L”) by and through counsel, pursuant to 4 CSR 240-4.020(2), and files this Notice of Intended Case Filing. In this regard, KCP&L respectfully states to the Missouri Public Service Commission (“Commission”):

1. KCP&L is a Missouri corporation with its principal office and place of business at 1200 Main Street, Kansas City, Missouri 64105. KCP&L is primarily engaged in the business of generating, transmitting, distributing, and selling electric energy in portions of eastern Kansas and western Missouri. KCP&L is an electric corporation and public utility as defined in Section 386.020, Mo. Rev. Stat. (2000), as amended. KCP&L provided its Certificate of Good Standing in Case No. EF-2010-0178, which is incorporated herein by reference.

2. Commission Rule 4 CSR 240-4.020 provides, in pertinent part, as follows:

(2) Any regulated entity that intends to file a case likely to be a contested case shall file a notice with the secretary of the commission a minimum of sixty (60) days prior to filing such case. Such notice shall detail the type of case and issues likely to be before the commission.

3. It is KCP&L’s intent to file an application pursuant to Section 393.140, and 4 CSR 240-2.060 for an accounting authority order that will allow KCP&L to establish construction accounting with respect to its ongoing La Cygne environmental project. While KCP&L is not certain that this matter will be considered a “contested case” pursuant to 536.010(4) RSMo., it is filing this notice out of an abundance of caution.

WHEREFORE, KCP&L submits to the Commission and its Secretary this Notice of Intended Case Filing.
