**NOTICE OF INTENDED CASE FILING**

COME NOW ITC Midwest LLC ("ITC") and Fortis Inc. ("Fortis"), by and through counsel, and file this Notice of Intended Case Filing, as follows:

1. ITC Midwest LLC is a limited liability company organized and existing under the laws of the State of Michigan and duly authorized to conduct business in Missouri. Its principal place of business is located at 27175 Energy Way, Novi, MI 48377. It operates certain limited transmission assets in Clark County, Missouri, with Commission approval as granted in Case No. EO-2007-0485.

2. Fortis Inc. is a corporation organized and existing under the laws of Newfoundland and Labrador, Canada, and through its subsidiaries owns and operates electric systems across Canada and in the United States and other locations. Its principal place of business is located at Fortis Place, Suite 1100, 5 Springdale Street, P.O. Box 8837, St. John's, Newfoundland and Labrador, Canada, A1B 3T2.

3. Commission Rule 4-CSR 240.4.020 provides, in pertinent part, as follows:

(2) Any regulated entity that intends to file a case likely to be a contested case shall file a notice with the secretary of the commission a minimum of sixty (60) days prior to filing such case. Such notice shall detail the type of case and issues likely to be before the commission.

4. ITC and Fortis intend to file a joint application pursuant to Section 393.190 RSMo. to seek any required approval of the merger of ITC into the businesses ultimately owned by Fortis as a result of Fortis' acquisition of ITC's parent, ITC Holdings Corp.

5. ITC and Fortis do not anticipate that their application will be a contested case, but file this notice out of an abundance of caution. They may file the application in less than 60 days from the date hereof and seek waiver of the remaining time delay for good cause.

WHEREFORE, ITC and Fortis submit to the Commission this Notice of Intended Case Filing.
