SECOND AMENDED APPLICATION BY DELETION

COMES NOW UtiliCorp United Inc. ("Applicant"), by and through counsel, and for its Second Amended Application in the captioned matter, states as follows:

- 1. On December 3, 1999, the Applicant filed an Application with the Missouri Public Service Commission ("Commission") for authority to acquire an ownership interest in an electric utility distribution business located in Brazil. The Commission docketed the filing as Case No. EM-2000-358.
- 2. On December 8, 1999, Applicant amended its Application to correct several typographical errors by interlineation.
- 3. Instead of requesting that the SEC issue a new 3(b) exemption to UtiliCorp Canada Corp. ("UCC"), UtiliCorp now plans to utilize an existing 3(b) certified entity. Thus, there is no longer a need for an SEC certification letter in substantially the form of Appendix 4 to the Application as set forth in paragraphs 9 and 10 of the Application.
- 4. In light of this development, Applicant further amends its Application by deleting therefrom paragraphs 9 and 10 in their entirety and, further, by withdrawing its request in subparagraph (2) of the prayer of the Application that the Commission send the certification letter to the

SEC concerning UCC in substantially the form of Appendix 4 of the Application.

- 5. No prejudice should result from this amendment of the Application because the withdrawal of Applicant's request for SEC certification in fact narrows and simplifies the relief requested from the Commission.
- 6. Applicant's Application heretofore filed on December 3, 1999, and as amended on December 8, 1999, in all other respects is hereby restated, ratified and confirmed.

WHEREFORE, having amended its Application as aforesaid, Applicant renews its request for authority to make the described investment all in accordance with its Application as hereinabove amended.
