**SECOND SUPPLEMENTAL INFORMATION AND VERIFICATION  
OF CO-MO COMM, INC. FOR DESIGNATION AS AN  
ELIGIBLE TELECOMMUNICATIONS CARRIER**


On September 27, 2018 CO-MO COMM, INC. ("CO-MO"), by its undersigned counsel submitted its Application for Designation as an Eligible Telecommunications Carrier ("ETC") in the State of Missouri ("Application"). On October 22, 2018, CO-MO received an email from the Missouri Public Service Commission Staff Counsel Department with a request for clarification or additional information to be provided. Staff's requests and CO-MO's responses to Staff's requests follow:

- 1. CO-MO COMM, INC. is registered with the MoPSC as an IVoIP provider under the name CO-MO COMM, INC. d/b/a Co-Mo Connect. The ETC application requests ETC status for solely CO-MO COMM, INC.. The supplement filed Friday states that CO-MO commits to solely conduct business under the name granted for ETC status, which will be CO-MO COMM, INC.. It also states the applicant does have a dba registered with the Secretary of State which is Co-Mo Connect and that CO-MO will not use any additional service or brand names beyond those disclosed. What name does the company intend to provide the service under? The company is currently registered with the MoPSC as CO-MO COMM, INC. d/b/a Co-Mo Connect and therefore should be granted ETC designation as such and provide the service using the full name or simply Co-Mo Connect.**

CO-MO COMM, INC.'s application should have stated that "CO-MO COMM, INC. d/b/a Co-Mo Connect" seeks ETC status. CO-MO requests that the PSC grant ETC status to "CO-MO COMM, INC. d/b/a Co-Mo Connect". CO-MO commits to solely conduct business under "CO-MO COMM, INC. d/b/a Co-Mo Connect" or "Co-Mo

Connect". Please see Exhibit A, attached, for the Secretary of State registration for Co-Mo Connect.


