**NOTICE CONCERNING ORDER DIRECTING ADDITIONAL NOTICE
AND REQUEST FOR APPROVAL**

COMES NOW Aquila, Inc. ("Aquila" or the "Company") and for its response to the Commission's Order Directing Additional Notice dated April 24, 2007, states as follows:

1. On April 24, 2007, the Commission issued an Order Directing Additional Notice (the "Order"). The Order directed that Aquila issue a notice to its customers no later in its next billing cycle concerning the transaction that is the subject of this case. The Order specified certain information to be provided in such a notice.

2. At the time the Order issued, notice to Aquila's customers had not yet been sent, however, a notice already had been prepared to be sent as a bill insert in the next billing cycle that commenced on April 25, 2007. The text of the notice reads as follows:

On April 4, 2007 Aquila, Great Plains Energy, and Kansas City Power & Light filed joint application seeking merger approval. Customers may send comments on Case No. EM-2007-0374 to: Secretary, Missouri Public Service Commission, P.O. Box 360, Jefferson City, MO 65102-0360 or www.psc.mo.gov.

Notices were included in bills mailed shortly after the issuance of the Order and such mailings will continue throughout the month of May.

3. The language of the notice is in substantial compliance with the Order.
