**CENTURYTEL OF MISSOURI, LLC'S  
NOTICE OF ADDITIONAL AMENDMENT TO  
APPLICATION FOR COMPETITIVE CLASSIFICATION**

COMES NOW CenturyTel of Missouri, LLC ("CenturyTel"), pursuant to Commission Rule 4 CSR 240-2.080, and for its Notice of Additional Amendment to Application for Competitive Classification respectfully states as follows:

1. On May 17, 2007, CenturyTel filed its verified Application for Competitive Classification pursuant to Section 392.245.5 RSMo. Cum Supp. 2005, and revised tariff sheets with an effective date of June 16, 2007, initiating the above-referenced matter. Pursuant to the original Application, CenturyTel requests that the Commission conduct a 30-day competitive classification review pursuant to Section 392.245.5(6) RSMo. and approve CenturyTel's Application for Competitive Classification for all its residential services, other than exchange access service, for the following exchanges: (a) Bourbon, (b) Branson, (c) Cabool, (d) Cassville, (e) Cuba, (f) Forsyth, (g) Kimberling City, (h) Mansfield, and (i) Troy; and for all of its business services, other than exchange access services, in the following exchanges: (a) Branson, (b) Crane, (c) Marshfield, (d) Ozark and (e) Troy.

2. On May 22, 2007, the Commission issued its *Order Directing Notice, Establishing Procedural Schedule, and Reserving Hearing Date* in this matter. No party has filed an application to intervene in this proceeding.

3. On June 1, 2007, pursuant to discussions with the Staff of the Commission and the Office of the Public Counsel, CenturyTel filed its Notice of Amendment to Application for Competitive Classification in this matter, deleting its specific request for competitive classification for Business Services in its Crane and Marshfield exchanges and for Residential Services in its Branson exchange.


4. Pursuant to additional discussions with the Staff of the Commission, CenturyTel hereby notifies the Commission and the parties that it is further amending the relief requested in this matter, by deleting the following specific request for competitive classification at this time:

Residential Services in its Troy exchange.

5. As stated in its previous Notice, CenturyTel will be filing substitute tariff sheets in this case and Tariff File No. JI-2007-0839 to effectuate the above amendment to its requested relief.

WHEREFORE, CenturyTel of Missouri, LLC respectfully submits its Notice of Additional Amendment to its previously filed Application for Competitive Classification.


