**NOTICE OF CHANGE APPLICATION**

2. The Company seeks authorization to provide video service in one additional political subdivision, Laclede County, which assesses a franchise fee of three percent (3%).

WHEREFORE, Fidelity requests the Commission issue its order granting the Company a supplemental video service authorization to serve Laclede County.






