MOTION TO CANCEL CERTIFICATES OF SERVICE AUTHORITY TO PROVIDE INTRASTATE TELECOMMUNICATIONS SERVICES AND TARIFFS

- 3L Communications Missouri, LLC ("3LCom") respectfully requests cancellation of its certificates of service authority to provide intrastate telecommunications services in the state of Missouri and related tariffs, pursuant to Section 392.410 RSMo and states:
- 1. 3LCom, a Missouri limited liability company with its principal office located at 108 S. Main St., Nevada, Missouri 64772, received certificates of service authority to provide intrastate telecommunications services in the state of Missouri from the Commission in an "Order Granting Certificates to Provide Basic Local, Nonswitched Local, and Interexchange Telecommunication Services and Approving Tariffs," issued February 2, 2012, in Case No. TA-2012-0201.
- 2. 3LCom has no customers in Missouri and no longer actively offers or provides intrastate services in Missouri (and has not since April 2015).
- 3. The Commission has the authority to cancel a certificate of service authority pursuant to Section 392.410.5 RSMo: "[a]ny certificate of service authority may be altered or modified by the [C]ommission after notice and hearing, upon its own motion or upon application

of the person or company affected." The Commission need not hold a hearing if, following proper notice and opportunity to intervene, no party requests a hearing.¹

4. Upon canceling 3LCom's Certificate of Service authority, the Commission should also cancel its Missouri tariffs.

WHEREFORE, 3LCom respectfully requests the Commission to grant this Motion and cancel 3LCom's certificates of service authority to provide intrastate telecommunications service in the state of Missouri and its related tariffs.
