# ORDER SUSPENDING PROCEDURAL SCHEDULE AND DIRECTING RESPONSE

On February 18, 2000, the parties herein filed their Unanimous Stipulation and Agreement (Stipulation) seeking the approval of the Commission for a settlement disposing of all issues in this case. While the Commission considers the parties' Stipulation, it will suspend the existing procedural schedule, including the hearing currently set for March 14-15, 2000.

The Commission also notes that the Stipulation indicates that the Staff of the Missouri Public Service Commission (Staff) shall submit to the Commission a memorandum and/or testimony explaining its rationale for entering into the Stipulation. However, the Stipulation does not specify when the Staff shall provide such filing. Since such input from the Staff will assist the Commission in resolution of this matter, the Commission directs that the Staff shall file a memorandum and/or testimony explaining its rationale for entering into the Stipulation. In the interest of moving towards a prompt resolution of this matter, the Commission directs that Staff file such memorandum and/or testimony no later than thirty days from the issue date of this order. If it is not feasible for the Staff to comply within the thirty days, the Staff shall so advise the Commission and shall suggest an alternative date.

#### **IT IS THEREFORE ORDERED:**

1. That the procedural schedule established herein by order issued on February 10, 2000, is suspended until further order of the Commission.

2. That the Staff of the Missouri Public Service Commission shall file, no later than April 10, 2000, a memorandum and/or testimony explaining its rationale for entering into the Unanimous Stipulation and Agreement.

3. That this order shall become effective on March 21, 2000.


