ORDER SCHEDULING LOCAL PUBLIC HEARINGS

On January 26, 1999, Laclede Gas Company (Laclede) submitted to the Commission tariffs reflecting increased rates for gas service provided to its customers in Missouri. On February 9, 1999, the Commission suspended Laclede's proposed tariffs. The case is set for evidentiary hearing on August 30, 1999, through September 3, 1999, at the Commission's office located in Jefferson City.

On April 30, 1999, Laclede filed a motion requesting that it be notified on or before May 14, 1999, if the Commission intended to hold local public hearings in this matter so that it could make the appropriate preparations for notification of its customers. Laclede suggested that public hearings be set in both downtown St. Louis and in Clayton as in previous rate cases before the Commission. No responses to Laclede's motion were received.

The Commission will conduct local public hearings in St. Louis and Clayton before the evidentiary hearing. Direct notice of the local public hearings shall be sent by Laclede, by an imprint on the customer's monthly billing, billing insert, first class letter, or postcard, to each

of Laclede's residential and commercial customers at least fifteen (15) days prior to the local public hearing date. The direct notice to customers sent by Laclede shall prominently state the time, date, and location of the local hearing regarding the proposed rate design. The Staff, the Office of the Public Counsel and Laclede shall develop mutually agreeable language to be contained in Laclede's direct notice to its customers.

The Commission will direct the Commission's Information Officer to send notice of the local public hearing to radio stations, television stations, and publishers of each newspaper located in Laclede's service area, as listed in the newspaper directory of the current Official Manual of the State of Missouri, and to members of the General Assembly representing customers in Laclede's service area. The Commission will also direct the Records Department of the Commission to serve a copy of this order upon the county commission of each county and mayor of each municipality within Laclede's service area.

That local public hearings are scheduled on Wednesday,

3. That Laclede Gas Company shall send notice, as directed in this order, to each of the company's residential and commercial customers at least fifteen (15) days prior to the local public hearing date.


