## AT&T MISSOURI'S NOTICE OF CORRECTION

AT&T Missouri<sup>1</sup> wishes to notify the Missouri Public Service Commission of a minor and inadvertent typographical error contained in Schedules 6(P), 7(P), 8(P) and 9(P) of AT&T Missouri witness Chris Read's Direct Testimony filed March 24, 2006, and that AT&T Missouri has refiled corrected schedules with this Notice.

In preparing these four schedules, AT&T Missouri used Adobe software to electronically insert both a "Proprietary" label in the document's header, and the schedule and page numbers in the document's footer. AT&T Missouri, however, has discovered that when it inserted the "Proprietary" header, the information for the footer (schedule and page numbers) apparently disappeared from the schedule. These individual schedules, however, were appropriately identified by schedule number and as "Proprietary" in EFIS. This information was also reflected in the labels of the icons for the individual documents that were electronically served on the parties on March 24, 2006. The Nonproprietary ("NP") versions of these schedules were not affected.

In order to avoid any possible confusion that may be caused by the omission of the schedule numbers and page numbers from the paper copies of these four schedules, AT&T
