AMEREN MISSOURI'S NOTICE OF ERRATA

COMES NOW Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri” or “Company”), and hereby notifies the Commission that its September 12, 2018, response to the Commission’s August 29, 2018 *Order Directing Filing* contained an error as, described below:

1. The Company’s response indicated that “the Staff has agreed that Ameren Missouri is entitled to recalculate the performance incentive award for Program Year 2 of its MEEIA Cycle 2 Plan” and went on to state that “the Company is entitled to recalculate (subject only to verification of the accuracy of the recalculation) its performance incentive award for the 2014 program year in accordance with the Court’s opinion and is further entitled to include the resulting sum for recovery in its next Rider EEIC adjustment filing.”

2. Those statements were largely accurate,¹ but the statements should have reflected the fact that the recalculation is to occur not only for Program Year 2 MEEIA Cycle 1 (2014) but also for Program Year 3 (2015). This is because the Staff's complaint and the Commission's now-

¹ The Staff did agree, in its September 6, 2018 Response to Commission Order Directing Filing, that the Company was entitled to recalculate its performance incentive award, but the Staff properly did not limit that recalculation to Program Year 2 (2014).

reversed order granting the Staff summary determination thereon had required different avoided cost estimates to be used to determine the performance award for the period October 1, 2014² through December 31, 2015.

3. The order recommended by the Company's response should therefore reflect that the recalculation should occur for the period October 1, 2014 through December 31, 2015.

4. The undersigned counsel apologizes for the oversight in accurately describing the full period affected by the Supreme Court's decision and for which the recalculation must be made.

WHEREFORE, Ameren Missouri submits this notice of errata.
