Chris Roepe discussed Noranda's situation and the need to move ahead with a legislative

approach that would benefit all customers.

Attendees then engaged in a discussion on the different elements of legislation being considered and generally how this regulatory framework would operate. Several attendees asked questions and expressed concerns which prompted discussions on how the different elements in the legislation would operate and potential changes to the bill to address concerns expressed.
