AMEREN MISSOURI'S NOTICE THAT REBATE PAYMENT LIMIT REACHED

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company"), and pursuant to the Missouri Public Service Commission's ("*Commission*") *Order Regarding Tariff* in the above-captioned case effective September 19, 2014, provides notice that the \$91.9 million rebate payment limit specified in the Non-Unanimous Stipulation in File No. ET-2014-0085 has been reached. In support hereof, the Company respectfully states as follows:

1. On May 23, 2014, Ameren Missouri filed an application to suspend payment of solar rebates in the above-captioned matter due to the Commission's approval of a Non-Unanimous Stipulation in File No. ET-2014-0085.

2. On August 20, 2014, the Commission issued an *Order Regarding Tariff*, effective September 19, 2014, wherein the Commission found that the tariff Ameren Missouri filed complied with the Non-Unanimous Stipulation and Agreement in File No. ET-2014-0085 ("*Order*"). However, in ordering paragraph 3, the Commission directed as follows: "The Company shall file a notice in this case, with supporting documentation, when it has reached the \$91.9 million rebate payment limit specified in the Non-Unanimous Stipulation in File No. ET-2014-0085."

3. In compliance with ordering paragraph 3 quoted above, the Company hereby files notice in this case that the \$91.9 million rebate payment limit specified in the Non-Unanimous Stipulation in File No. ET-2014-0085 has been reached.

4. In further compliance with ordering paragraph 3, the following table summarizes the rebate amounts included in prior Ameren Missouri general rate case dockets and provides supporting documentation that the \$91.9 million rebate payment limit has been reached.

5. Ameren Missouri apologizes for the delay in filing this Notice as it was not submitted at the time of the resolution of File No. ER-2019-0335 when the rebate payment limit was hit. Ameren Missouri asks the Commission to please accept this Notice out-of-time.

WHEREFORE, Ameren Missouri respectfully requests that the Commission accept this *Notice* in compliance with ordering paragraph 3 of the *Order* and out-of-time, and for any other relief the Commission deems appropriate.
