1. On June 14, 2006, the Staff of the Commission and AmerenUE filed a Stipulation and Agreement in this case.
2. On August 10, 2006, the Commission issued its Order Approving Stipulation and Agreement (Order).
3. The Commission's Order approved Stipulation and Agreement and required AmerenUE to pay \$2,000 into the public school fund no later than September 11, 2006.
