Pursuant to 4 CSR 240-28.030(9), MCImetro Access Transmission Services LLC (“MCI LLC”) hereby notifies the Commission that it has changed its name to MCImetro Access Transmission Corp. (“MCI Corp.”). The company respectfully requests that the Commission issue an updated certificate reflecting the new name. MCI LLC provides competitive local exchange service pursuant to the order in Case No. TA-96-355, dated February 21, 1997. This change does not affect the rates, terms or conditions of services provided to MCI LLC’s customers. All EFIS contacts for MCI Corp. will remain the same.

The name change was filed with the Missouri Secretary of State on November 2, 2016. Customers were notified of the name change via bill insert in the month of September, a copy of which is attached. MCI LLC is also providing a copy of its updated tariff pages reflecting the name change.






