**RESPONDENT’S SUGGESTIONS IN RESPONSE TO ORDER DIRECTING FILING**

1. On April 6, 2010, the Commission ordered the parties to suggest how they wished to proceed in light of the Commission’s February 16, 2010 Order requiring the parties to appear at the March 1, 2010 prehearing conference, and Complainant’s subsequent letter filed March 17, 2010 stating that she had thought she did not have to appear at that conference (the “Order”).
