Section 536.200.3, RSMo, requires the Commission to review the fiscal note or estimated cost declaration attached to its amendment of Commission Rule 20 CSR 4240-125.040 at the end of the first full fiscal year following the implementation of the amended rule. The amended rule became effective on March 30, 2021.

As part of its review, the Commission will invite interested stakeholders to offer comments about the accuracy of the fiscal impact stated in the fiscal notes or estimated cost declaration that accompanied the rulemaking.

## THE COMMISSION ORDERS THAT:

1. Comments regarding the actual cost of compliance with the amendment of Commission Rule 20 CSR 4240-125.040 shall be filed with the Commission by July 20, 2022.
2. The Commission's Data Center shall provide a copy of this order to all persons who filed comments regarding the rule, and to all Commission-licensed manufactured home installers in the state of Missouri.

3. This order shall be effective when issued.
