
This letter replaces a letter dated May, 22, 200, similar in content, but which tai-led in the earlier Adoption Notice to specify dates certain for the "Date of Issue" and the "Effective Date". Those dates now appear in this letter and. the attached Adoption Notice. Thank you for your assistance.

This is to advise that Missouri Pipeline Company, a Delaware corporation regulated by the Missouri Public Service Commission ("Commission"), is planning to convert to a limited liability company ("LLC") udder Delaware law. According to the procedure set forth by the Commission in In *The Matter of the Joint Application of Claricom Networks, Inc., of al.,* Case No. TM-2091-669, and our counsel's previous conversation with you, for Commission purposes this simply requires the filing for a name change pursuant to 4 CSR 240-2.060(16). Accordingly, pursuant to 4 CSR-=2402:060(16), the following information is provided.

The old name of the company was Missouri Pipeline Company; the new name will be Missouri Pipeline Company,, LLC. Accompanying this letter are (one original and eight copies) of an adoption notice. with a Date of Issue of May 31, 2002 and an Effective Date of July 1, 2002, as well as: a tale sheet. Since the existing company will simply be converted to an LLC upon. filing the appropriate documents with the offices of the Delaware Secretary of State and Missouri Secretary of State, the necessary filing with the Missouri Secretary of State cannot be made until Commission approval is received. Upon receipt of approval from the Commission, the appropriate filings will be made with the offices of the Delaware Secretary of State and Missouri Secretary of State, and the Missouri Secretary of State certificate **will** be late-filed -with the Commission.

Please have the Commission: issue an "order recognizing of the **name change, the adoption of the** tariffs and certificates of convenience and necessity-in-the name of Missouri-Pipeline Company, LLC and any other necessary matters. Also, please file - stamp the enclosures and return to me in the self-addressed, stamped envelope which is enclosed. Thank YOU for your assistance in this matter,
