MOTION TO SET HEARING DATE

COMES NOW The Empire District Electric Company ("Empire") and Southwest Electric Cooperative ("Southwest"), hereinafter referred to collectively as "Applicants," by and through their respective counsel, and for their Motion to Set Hearing Date respectfully state as follows:

- 1. The Applicants and other parties seek an order from the Commission setting an evidentiary hearing in this case on August 6, 2002.
- 2. The Applicants filed this verified application on June 7, 2002. In brief, it requests an order approving a territorial agreement for areas in and near Strafford, Missouri. No customers of the Applicants will be required to change suppliers as a result of the approval of the agreement. The Commission sent out an "Order and Notice" in this matter on June 12, 2002, setting an intervention deadline of July 2, 2002. No party sought intervention prior to the deadline. The Office of the Public Counsel has indicated that it will not oppose the application.

- 3. State law requires that the Commission rule on the application within 120 days of June 7, 2002. State law also mandates a hearing. § 394.312.4 RSMo 2000. The Order and Notice issued on June 12 required the Applicants, the Staff of the Commission, and the Office of the Public Counsel to file a proposed procedural schedule on or before July 15, 2002, with a hearing to take place on or before August 13, 2002.
- 4. The Applicants and Staff have consulted the Commission's calendar and discussed the setting of a hearing with the Regulatory Law Judge. The earliest open hearing date is early September. The Applicants seek an earlier hearing date due to their mutual perception that this case will be uncontested, and approval will produce certainty as to the identity of an electric supplier within a developing subdivision inside the Strafford city limits, and thereby avoid possible delays in new customers receiving electric service.
- 5. The parties expect the hearing to be brief. Based on prior similar situations before the Commission, the Applicants believe the hearing should consume less than half an hour. Counsel and witnesses for the Applicants and the Staff are all available on August 6, 2002, and desire that a hearing be set for this case on that date. The Applicants are aware that the Commission has another hearing set for that date. The Applicants do not wish to interfere with the existing hearing and therefore suggest that the hearing in this case could either be held without the presence of the Commissioners, or could be scheduled at a logical breaking point in the other hearing, e.g. 1 p.m., to accommodate any Commissioners who wish to attend. Such a time

would also aid the witnesses and counsel for Southwest who have to travel from southwest Missouri to attend the hearing here in Jefferson City.

6. Counsel for the Staff and the Office of the Public Counsel have reviewed this motion prior to its filing and have consented to it.

WHEREFORE, the Applicants request that the Commission schedule the evidentiary hearing in this case at 1 p.m. on August 6, 2002.
