- 1. On Friday, July 24, 2009, the Commission issued its *Order Further Suspending Tariffs and Setting Evidentiary Hearing* in which it directed the parties to file a "List and Order of Witnesses" on August 3, 2009, in each of the following respective cases: Case No. WR-2009-0227, Case No. SR-2009-0226, and Case No. WR-2009-0229 as listed above.
