## MOTION TO SUBMIT ADVISORY COMMITTEE RECOMMENDATION FOR DISBURSEMENT FROM THE RECOVERY FUND

COMES NOW the Director of the Manufactured Housing and Modular Units Program (Manager) of the Missouri Public Service Commission (Commission), by and through counsel, on behalf of the Manufactured Housing Consumer Recovery Advisory Committee (Advisory Committee), and for its Recommendation for Disbursement from the Missouri Housing Consumer Recovery Fund (Recovery Fund) hereby states:

- 1. The Recovery Fund is established for the purpose of paying consumer claims under commission created procedures.<sup>1</sup>
- 2. A committee shall assist in the evaluation of all claims submitted by consumers.<sup>2</sup>
- 3. The Commission promulgated Commission Rule 4 CSR 240-126 establishing the advisory committee,<sup>3</sup> setting forth the standards for consumers to receive disbursement from the Recovery Fund,<sup>4</sup> and the methods by which consumers mav submit claims.5

- 4. The advisory committee investigates and determines whether the requirements of the rule have been satisfied and presents its findings to the Commission in the form of a recommendation.<sup>6</sup>
- 5. The recommendation of the advisory committee for disbursement of funds from the Recovery fund shall be subject to approval of the Commission.<sup>7</sup>
- 6. Pursuant to authority granted by § 700.041, RSMo., the Advisory Committee investigated a consumer claim filed with the Commission on July 19, 2018.
- 7. Pursuant to Commission Rule 4 CSR 240-126.020(4), the Advisory Committee has prepared for the Commission's consideration a recommendation for disbursement.

WHEREFORE, the Advisory Committee submits this Recommendation for Disbursement from the Recovery Fund for the Commission's consideration and approval.
