5. SWBW inadvertently missed the intervention due date as a result of changes in SWBW's legal and regulatory representation in the state of Missouri.

5. SWBW seeks to intervene in this proceeding for the following three reasons: First, SWBW's interest in this proceeding is different from that of the general public. 6. No party will be harmed by SWBW's Request for Leave to File Application To Intervene Out of Time and/or Application to Intervene.




