## MOTION TO EXTEND DEADLINE FOR FILING OF STAFF RECOMMENDATION

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and submits its <u>Motion to Extend Deadline for Filing of Staff Recommendation</u> (<u>Motion to Extend</u>) as follows:

- 1. On April 13, 2010, Staff, The Office of the Public Counsel (OPC), and Aqua Missouri entered into a <u>Unanimous Partial Stipulation and Agreement Regarding Count IV</u> (Partial Stip Regarding Count IV).
- 2. On April 21, 2010, the Commission issued its <u>Order Approving Stipulations and Agreements</u>, approving the <u>Partial Stip Regarding Count IV</u>, ordering the parties to comply with its terms, and directing Staff to file a recommendation within seven (7) days of the submission of a tariff filing mandated by the terms of the <u>Partial Stip Regarding Count IV</u>.
- 3. The requirement to submit the above-referenced tariff filing is found in provision number fifteen (15) of the <u>Partial Stip Regarding Count IV</u>, which states as follows:

In addition, within sixty (60) days of the effective date of a Commission order approving this stipulation, the Company agrees to supplement its tariff(s) with the Commission in order to tariff

the Company's procedures for rendering estimated bills, including, but not limited to those related to the water meter removal and inspection schedule found at Commission Rule 4 CSR 240-10.030(38). Staff reserves the right to state a position on these tariff changes in the context of the subsequent tariff filing.

4. On June 21, 2010, the Company filed a series of tariff sheets in response to the above-listed provision of the Partial Stip Regarding Count IV.

5. Based upon informal communications between Staff and Aqua Missouri regarding Staff's review of the tariff sheets submitted on June 21, 2010, Aqua Missouri plans to file a series of substitute tariff sheets in the near future.

6. In order to provide Staff with sufficient time to review the substitute tariff sheets, Staff requests that the Commission extend the deadline for Staff to file its recommendation in this matter until July 6, 2010, which gives Staff seven (7) days to file its recommendation as stated in the Order Approving Stipulations and Agreements.

**WHEREFORE**, Staff recommends that the Commission issue an order extending the deadline for Staff to file its recommendation until July 6, 2010.
