For filing on behalf of Aquila, Inc. ("Aquila") please find attached an electronic copy of the *natural gas* tariff sheets listed on the attached Appendix A. The proposed tariff sheets contain an issue date of September 17, 2004, and a proposed effective date of October 17, 2004.

The purpose of this filing is to implement an experimental low income program consistent with the Stipulation and Agreement approved by the Commission in Case No. GR-2004-0072.

On August 10, 2004, Aquila previously filed proposed tariff sheets for this purpose (YG-2005-0106, proposed effective date October 1, 2004). This week the Staff of the Commission asked Aquila to make certain changes to those tariff sheets and further requested that Aquila withdraw the earlier tariff sheets and make a new filing containing the modified provisions. Aquila earlier this afternoon withdrew the prior filing (YG-2005-0106).

Aquila still seeks to have tariff sheets for this program effective by October 1, 2004. Doing so will allow the local action agency to start qualifying low income participants during the month of October, prior to winter. Accordingly, Aquila is also filing herewith a Motion for Expedited Treatment asking that the Commission allow the proposed sheets to go into effect on October 1, 2004.
