**AMENDMENT TO APPLICATION AND MOTION FOR LEAVE TO AMEND**

COMES NOW Assist Wireless, LLC (“Assist Wireless” or “the Company”) and files this Amendment to its Application filed in this matter on May 27, 2011. In accordance with 4 CSR 240-2.080 (20), the Company respectfully requests leave of the Commission to amend its Application for Designation as an Eligible Telecommunications Carrier (ETC) as set out below, to correct an inadvertent factual misstatement in the Application as-filed.

**The Amendment:**

Section II of the Application (entitled, “Assist Wireless Satisfies the Statutory and Regulatory Prerequisites for Designation as an ETC in Missouri”) begins on page 5 of the Application. On page 9 (under Section II. C. “The Company Shall Use its Own Facilities, or a Combination of its Own Facilities and Resale of Another Carrier’s Services”), *the existing language of Section II. C. is hereby deleted and replaced with the following:*

Pursuant to 47 U.S.C. § 214(e)(1)(A) and 47 C.F.R. § 54.201(d)(1), the Company shall use its own facilities or a combination of its own facilities and resale of another carrier’s services to offer the services that are supported by Federal universal service support mechanisms. The Company has its own switch through which involved telecommunications traffic will be routed for the provision of one or more of the supported services that are supported

by Federal universal service support mechanisms, and which will be used in combination with the network architecture being provided from an underlying wireless provider that the Company obtains at resale.

The Amendment corrects a statement in the Application that Assist leases a switch under a capital lease agreement. Actually, Assist has its own switch.

**Motion for Leave to Amend:**

Leave to amend the Application will not harm any other Party. No motions to intervene were filed in this matter and no schedule of proceedings is in place. The amendment will facilitate Staff's review of the Application by correcting a factual misstatement inadvertently made in the original Application on May 27, 2011, for which the Company and its counsel apologize.

WHEREFORE, Assist Wireless, LLC respectfully requests that the Commission grant leave to amend its Application in this matter; and further submits the amendment to the Application set out above.
