COMES NOW North By NortheastCom LLC ("NBNE or Applicant") who requests a Certificate of Service Authority to provide competitive intrastate interexchange telecommunications services between and among locations within the state of Missouri pursuant to Section 392.440, RSMo 2000, an order classifying Applicant as a competitive telecommunications carrier, and an order waiving or suspending certain Commission rules and statutory provisions pursuant to Section 392.440, and an order waiving or suspending certain Commission rules and statutory provisions pursuant to Section 392.420. In support of its request, Applicant provides the following information:

1. North By NortheastCom LLC was incorporated on December 26, 2001, under the laws of the State of Delaware.

2. NBNE proposes to offer directory assistance services throughout the state of Missouri as a part of a nationwide service.

NBNE has no plans to install or construct transmission facilities in Missouri.

NBNE has contracted the services of ACI Billing Services for LEC, direct and credit card billing. Their toll free telephone number for customer inquiries and complaints is 800-944-9646. The Company may also bill the Customer, in which case the toll free telephone number is 800-933-4034.

3. NBNE's statutory representation in the state of Missouri is:

- 4. NBNE intends to provide resold long distance telecommunications service to business and residential customers on a twenty-four (24) hour a day, seven (7) day a week basis, originating and terminating throughout the state of Missouri.
- 5. NBNE possesses managerial and technical expertise to provide resale interexchange telecommunications services.
- **6.** NBNE possesses the financial ability to provide the requested services.
- 7. NBNE's tariff contains the rules and regulations applicable to its customers, a description of the services offered, and a list of rates associated with such services is being filed simultaneously with this application showing a forty-five (45) day effective date.
- 8. NBNE requests classification as a competitive telecommunications company operating within the state of Missouri. NBNE further requests classification of services described in their tariff as competitive services.

- **9.** Applicant will not unjustly discriminate among its customers, which discrimination is prohibited pursuant to Section 392.200.
- 10. Applicant, pursuant to Section 386.570, will comply with all applicable Commission rules except those which are specifically waived by the Commission pursuant to a request filed by the Applicant.
- 11. NBNE does not offer Operator Services.

Section 392.320 - Stock dividends

Section 392.330 - Issuance of securities, debt and notes

Section 392.340 - Reorganization

The above referenced rules and statutory provisions have been waived with regard to other

interexchange carriers in prior cases. These rules or statutory provisions are principally

designed to apply to noncompetitive telecommunications carriers. It would be inconsistent

with the goal and purpose of Section 392.530 to apply them to a competitive

telecommunications carrier such as the Applicant.

14. Applicant has no annual reports or regulatory assessment fees that are overdue in Missouri.

15. Applicant has no pending actions or final unsatisfied judgments or decisions against it from

any state or federal agency or court which involve customer service or rates, which action,

judgment, or decision has occurred within three (3) years of the date of this Application.

WHEREFORE, North By NortheastCom LLC, respectfully requests the Commission to grant

it a certificate of service authority to offer competitive intrastate interexchange telecommunications

service within the state of Missouri; an order classifying it as a competitive telecommunications

company providing competitive service; an order suspending, waiving or modifying the above

referenced rules and statutory provision as they relate to the regulation of the Applicant in the state of

Missouri, and for such further orders as the Commission deems appropriate.


