**AMEREN MISSOURI'S DEMAND-SIDE PROGRAM  
ANNUAL REPORT FOR 2013**

**COMES NOW** Union Electric Company, d/b/a Ameren Missouri (Ameren Missouri or the Company), and pursuant to 4 CSR 240-20.093(8) and 4 CSR 240-3.163(5), files its Demand-Side Program Annual Report for 2013 and states as follows:

1.     Missouri Public Service Commission's (Commission) Missouri Energy Efficiency Investment Act (MEEIA) regulations require utilities with one or more approved demand-side programs to file a Demand-Side Program Annual Report no later than 60 days after the end of each calendar year.

2.     Exhibit 1 to this pleading is Ameren Missouri's Demand-Side Program Annual Report for its 2013 MEEIA programs (an Excel Workbook having multiple tabs). Tab 1 of Exhibit 1 to this pleading is an index which sets forth the requirements of 4 CSR 240-3.163(5)(A) and indicates where the information responsive to each specific requirement can be found.

3.     Because Ameren Missouri did not have adjustments of its demand-side rates between general rate proceedings, the Company is not required to provide the information listed in 4 CSR 240-3.163(5)(B).

4.     As required by the Commission's regulations, the Company is serving a copy of this report on each party to its last MEEIA case, File No. EO-2012-0142.

**WHEREFORE**, Ameren Missouri requests the Missouri Public Service Commission accept its Demand-Side Program Annual Report for its 2013 MEEIA programs.
