SECTION 2 - RULES AND REGULATIONS (CONT'D)

2.7 Taxes and Fees

- 2.7.1 Service may be subject to State and/or local taxes (e.g., gross receipts tax, sales tax, and municipal utilities tax) and/or fees (e.g., intrastate access charges and contributions to the State universal service program), if Service originates and terminates in the State. An amount equal to such taxes and fees shall be charged to the Customer in addition to the charges stated in this Tariff. All charges related to such taxes and fees shall each be shown as a separate line item on the Customer's monthly invoice.
- **2.7.2** Service shall not be subject to taxes for a given jurisdiction if Customer provides the Company with written verification, acceptable to the Company and to the relevant taxing jurisdiction, that Customer has been granted a tax exemption.
- 2.7.3 The Company may also include among such fees and surcharges any Local Access charges, whether for originating or terminating Local Access, charged against the Company for originating or terminating intrastate interexchange communications
- **2.7.4** All such fees and surcharges subject to MoPSC jurisdiction, except taxes and franchise fees, will be submitted to the MoPSC for prior approval.
