**STAFF’S REPORT CONCERNING RESPONSE TO
THE COMMISSION’S ORDER DIRECTING FILING**

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”) and in response to the Commission’s April 17, 2003 Order Directing Filing states:

1. The Commission directed the utility companies in the state to respond to Staff’s questionnaire concerning emergency planning. Staff has received responses to the Commission’s Order from most of the utility companies in the state.

2. Attached is a list of the companies that have not responded. Staff has checked the Secretary of State’s website to eliminate those companies who are no longer incorporated in this state and has followed agenda minutes to remove companies that are no longer certificated in Missouri. Despite this effort, there may still be some companies on the list that are no longer providing any type of utility service.

3. With this pleading, Staff is filing its report, however, Staff continues to receive responses, from utility companies, some as a result of contact by Staff and others as a result of urging by utility associations. Staff will continue to update the Commission periodically as companies continue to comply with the Commission’s Order. If it is acceptable to the Commission, the next report will be submitted August 14, 2003.

4. At this time, Staff recommends that the Companies that have responded may be removed as parties to this case.

WHEREFORE the Staff requests that the Commission accept its report in accord with the Commission's April 17, 2003 Order directing Staff to report to the Commission, and order that the staff's next report be due on August 14, 2003.
