MOTION FOR EXPEDITED TREATMENT

COMES NOW Missouri Gas Utility, Inc. (MGU) and, and, in accordance with Missouri Public Service Commission (Commission) Rule 4 CSR 240-2.080(16), moves the Commission for expedited treatment of MGU's tariff filed on November 7, 2007:

1. On November 6, 2007, the Commission issued its Order Granting Certificate of Convenience and Necessity. In that order, the Commission directed MGU to file tariff sheets describing the new service area. The Commission further ordered that MGU shall not serve the new service area before such tariff sheets become effective.

2. Concurrently, with the filing of this Motion, MGU filed tariff sheets in order to comply with the Commission Order (1st Revised Sheet No. 2 and 2nd Revised Sheet No. 4) (provided herewith as **Appendix A**). This tariff sheet carried a proposed effective date of December 7, 2007 (30 days), and was assigned tracking number YG-2008-0306.


3. The primary purpose of the requested certificate is to provide service to a particular customer that has requested service. It is anticipated that construction necessary to provide service to that customer will be completed by November 26, 2007. Accordingly, MGE seeks the Commission's order allowing the proposed tariff sheets to go into effect on November 26, 2007.

4. The subject tariff sheets and this Motion have been filed as soon as possible after

the issuance of the Commission's Order Granting Certificate of Convenience and Necessity. Allowing MGU to provide service that is otherwise unavailable to a customer desiring such service in an expedited manner serves the public interest.

WHEREFORE, for the foregoing reasons, MGU respectfully requests the Commission to grant this Motion for Expedited Treatment and approve MGU's proposed tariff sheets (YG-2008-0306) effective November 26, 2007.


