## MOTION FOR EXPEDITED TREATMENT

COMES NOW RDG Development, LLC (RDG), and, in accordance with Missouri Public Service Commission (Commission) Rules 4 CSR 240-2.080(16) and 4 CSR 240-2.065(2), moves the Commission for expedited treatment of RDG's tariff sheets filed on December 18, 2009:

1. On December 9, 2009, the Commission issued its Order Granting Certificate of Convenience and Necessity. Among other things, the Commission directed in that Order that RDG submit a complete tariff. RDG may not bill customers for service until the tariff is approved and made effective.

2. Concurrently with the filing of this Motion, RDG filed a complete tariff to govern its provision of sewer service (See the attached). This tariff filing carried a proposed effective date of January 17, 2010 (30 days), and was assigned tracking number YS-2010-0397. The basis for the tariff was the Commission Staff's model sewer tariff.

3. MGE seeks the Commission's order allowing the proposed tariff sheets to go into effect on January 1, 2010.

4. The certificated area encompasses one existing development (Greenwood

Hills Subdivision) whose sewer system has not been regulated by the Commission. No other sewer service is currently available in this area. The subject sewer system has already been constructed and is in operation. Now that the certificate and an initial rate has been approved, RDG should be allowed to charge for the services it is providing at the earliest convenience.

5. The subject tariff sheets and this Motion have been filed as soon as possible after the issuance of the Commission's Order Granting Certificate of Convenience and Necessity.

WHEREFORE, for the foregoing reasons, RDG respectfully requests the Commission to grant RDG's Motion for Expedited Treatment and approve RDG's proposed tariff (YS-2010-0397) effective January 1, 2010.
