Enclosed for filing with the Missouri Public Service Commission ("Commission") on behalf of Missouri-American Water Company ("MAWC"), please find in electronic format certain sewer tariff sheets (list attached).

These tariff sheets are being filed to comply with the Commission's Order Approving Application For Certificate of Convenience and Necessity issued on April 14, 2015. These tariff sheets are designed to establish a sewer tariff book (P.S.C.Mo No. 21) to govern the provision of service to the subject area. Each of the tariff sheets bears an issue date of April 30, 2015, and a proposed effective date of May 30, 2015. MAWC will also file this date a Motion for Expedited Treatment asking that the tariff sheets be allowed to go into effect on May 22, 2015, the projected closing date for the underlying transaction.

Please note that the rates reflected in these tariff sheets are the same as those currently charged by the City of Arnold, with one exception. Arnold has charged a capacity fee of \$2,500.00. MAWC proposes to charge a capacity fee of \$1,500, which will be equal to that charged in MAWC's Cedar Hill District. This capacity fee is necessary because additional fees are owed to MSD, which will treat the wastewater, based upon the addition of customers.
