## SECOND MOTION FOR EXTENSION

COMES NOW Missouri-American Water Company ("MAWC") and states the following to the Missouri Public Service Commission ("Commission") as its Second Motion for Extension:

- 1. On March 2, 2011, MAWC filed a Motion for Extension, asking for additional time to respond to Staff's recommendation. The Commission granted this motion on March 2, 2011, and thereby provided the parties until March 17, 2011, to reply to the Staff Recommendation.
- 2. The parties have met twice and believe that progress has been made toward an agreement that would resolve this matter. However, it is unlikely that the parties will be able to complete this process and file a document(s) memorializing an agreement by March 17, 2011.
- 3. Accordingly, MAWC proposes that date for the parties' responses to the Staff Recommendation be further extended until March 28, 2011, to allow for the completion of the parties' discussions.
- 4. The undersigned counsel has discussed this proposed extension with counsel for Aqua Missouri, Staff and the Office of the Public Counsel. Counsel for all parties have indicated

that they support the proposed extension.

**WHEREFORE**, MAWC respectfully requests that the due date for parties' responses to the Staff Recommendation be further extended until March 28, 2011.
